When applying for a Commercial New Construction (CNC) incentive through the Energy Solutions for Business Program from FirstEnergy's Pennsylvania utilities, the design team is eligible to receive a design team incentive for time spent on CNC program activities (i.e. attending meetings, providing information such as plans and submittals, etc). When submitting this form, the customer is granting approval for the design team incentive to be paid directly to the design team member listed in the authorization box below. Please note the following:

- Customers must authorize the payment of any incentives to a non-participant (any design team member). Without the customer's consent, an incentive check will not be issued to a design team member.
- This form is applicable to the Energy Solutions for Business Program offered by FirstEnergy's Pennsylvania utilities; a separate authorization must be submitted for each application.

This authorization may be cancelled or changed by the customer at any time prior to final application approval by providing a written notice to the program. Changes and cancellations will result in a confirmation email to both the customer and the design team member.

A signed W-9 form is required for all parties designated to receive incentives. No portion of an approved incentive will be paid to either party until all required documentation is received by the program.

PA customers who have existing contracts with third party demand response service providers that were executed before June 1, 2021 (i.e., the start of Phase IV of Act 129 EE&C), have the option of retaining the PJM capacity rights associated with EE&C projects when participating in FirstEnergy PA Act 129 energy efficiency and peak demand reduction programs.
