RETRO-COMMISSIONING

This program involves tuning and calibration of existing building systems. Over time, typical building systems go out of calibration and require tuning to maintain ongoing efficiency. Eligible retro-commissioning improvements include optimizing setpoints, system control sequences and HVAC equipment runtime schedules. Retro-commissioning improvements can save as much as 20% on energy bills and may be eligible for up to \$10,000 to cover the cost of an in-depth energy audit.
